*Drug Supply Chain Security Act (DSCSA) Requirements Overview

The following interrelated statutory components go into effect on November 27, 2023, requiring all manufacturers, wholesalers, and dispensers to be compliant with DSCSA regulations for all transactions related to a covered medication involving change in custody or ownership.

1. **Interoperable Exchange.** Trading partners must exchange required transaction information (TI) and transaction statements (TS) in a secure, electronic, interoperable manner, and the TI must include the product identifier at the package level.
2. **Interoperable Verification.** Trading partners must be able to verify the product identifier on a package or sealed homogenous case in a secure, electronic, interoperable manner.
3. **Interoperable Tracing.** Trading partners must maintain TI and TS in response to a request for it and to promptly facilitate gathering the information necessary to produce the TI for each transaction going back to the manufacturer.
